



COVID Acknowledgment and Release Form

By attending a function sponsored by The Philadelphia Chorus, you agree to the following:

I acknowledge that COVID-19 is contagious and that public health authorities recommend practicing social distancing to avoid exposure to the virus. I further acknowledge that The Philadelphia Chorus ("TPC") has put in place preventative measures to reduce the spread of COVID-19.

I voluntarily seek to attend a function sponsored by TPC, and acknowledge that I may be increasing my risk of exposure to COVID-19 by doing so, whether the TPC function is outdoors or inside a building.

I acknowledge that I must be fully vaccinated (defined as 2 weeks past the final injection) with one of the COVID-19 vaccines and show proof of vaccination before attending any TPC functions. I further acknowledge and agree that I must comply with all set procedures to reduce the spread while attending TPC functions.

I understand that TPC makes no guarantee that I will not become infected with COVID-19 if I choose to attend a TPC function. I assume all risk associated with attending a TPC function.

I will not attend a TPC function if any of the following apply to me:

- I experience any symptom of illness related to COVID-19 such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell, or
- I have traveled within 14 days of the TPC function to any location within or outside the United States of America that has a significant COVID-19 infection rate, or
- I believe I have been exposed to someone with a suspected and/or confirmed case of COVID-19 within 14 days of the TPC function, or
- I have tested positive for or been diagnosed with COVID-19 and not yet been cleared as non-contagious by my physician, or a State or local public health authority.

By agreeing to attend a TPC function, I knowingly and voluntarily release and agree to hold The Philadelphia Chorus, its officers, board members, singers, accompanist, Artistic Director, and other agents ("TPC") harmless from, and waive on behalf of myself, my heirs, and any personal representatives, any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself, my income and/or property that may be caused by any act, or failure to act by TPC resulting from exposure to COVID-19. I understand that this release discharges TPC from any liability or claim that I, my heirs, or any personal representatives may have against TPC with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection with TPC functions, including rehearsals and performances.

The Philadelphia Chorus has put in place the following preventative measures at all TPC functions to reduce the spread of COVID-19:

- All attendees must provide proof of full vaccination. (Unvaccinated children under 12 must show a negative PCR test within the past 72 hours.)
- All attendees must wear a mask that covers the mouth and nose.
- Seating arrangements will comply with social distancing guidelines.
